The body's own defences are mobilised when taking purple coneflower juice, which generally results in increased resistance in the whole organism. This fights a variety of germs and damaging foreign particles. Echinacea effectively reinforces the body's tissues so that protection against the penetration of bacteria is improved. This is used as biological immunity and therefore gives a preventative effect against infections.

Substance group / indication group mofde of action

Herbal medicinal product for cold symptoms.

Fields of application: Natural Medicinal Purple Coneflower Plant Juice is produced from a plant related to the sunflower. The ancient Indians in America, who discovered the healing power of this medicinal plant, only used the purple coneflower (lat: Echinacea) when fresh as long as the ingredients were fully maintained and pure.

Areas of application

Supportive treatment for frequently returning (recurrent) infections in the airways and urinary tract.

Contraindications

When should Natural Medicinal Purple Coneflower Plant Juice not be used?

It should not be used in case of over-sensitivity against the ingredients or composite plants. Due to general considerations, Natural Medicinal Purple Coneflower Plant Juice should not be taken in case of progressing system illnesses such as tuberculosis, leukaemia or leukaemia-type illnesses, inflammatory illnesses in the connective tissue (collegenosis), multiple sclerosis, AIDS infections, chronic viral illnesses and other autoimmune illnesses.

Precautions for application and warning advice

When used for airways infections: Please consult a doctor in case of ongoing complaints, breathing difficulties, fever or phlegm containing pus or blood.

When used for urinary tract infections:

Consult a doctor if there is blood in the urine, a fever, or symptoms that last longer than 5 days.

Sufficient research has not yet been conducted concerning the effect of this medicinal product during pregnancy and breastfeeding and on children under 4 years. It should therefore not be used during pregnancy and breastfeeding or on children under 4 years.

There are no known interactions.

Dosage instructions, type and duration of application:

How much Natural Medicinal Purple Coneflower Plant Juice should be used and how often? Unless prescribed otherwise, adults and youths over 16 years of age take 5ml pressed juice, undiluted or with a little fluid, two times per day before meals. Children and youths between 10 and 16 years take between 6ml once per day and 4ml twice per day. Children between 4 and 10 years of age take to ml 2 to 3 times a day.

Please use the enclosed dosage beaker.

Purple Coneflower Natural Medicinal Plant Juice should not be taken longer than two weeks uninterrupted.

Shake the bottle before use!

Side effects

Which side effects can occur as a result of taking Purple Coneflower Natural Medicinal Plant Juice? Allergic reactions may occur in some individual cases. Skin rashes, itching, rare facial swelling, breathing difficulties, dizziness and a drop in blood pressure have been observed in medicines with preparations containing purple coneflower. If this occurs, stop taking the medicinal product and consult a doctor.

If you notice any side effects, please consult your doctor or pharmacist or medical professionals. This also applies to side effects not listed in this information leaflet. You can also register side effects directly with the Bundesinstitut für Arzneimittel und Medizinprodukte, Abt.

Do not store above 30 °C. Store the bottle in the fridge and use within 3 weeks of opening.

Active medicinal ingredient:

100 ml of pressed juice made of fresh, blossoming purple coneflower herb (Echinacea purpurea [L.] MOENCH) (1:0.65 – 0.85).

Dosage form and pack size:

Pack with 1 x 200 ml bottle of pressed juice
