



## GELASTIN® Liquid extra

Dietary supplement with collagen peptides (FORTIGEL®), vitamins, magnesium, rosehip extract, sugar and sweetener.

Flavour: Blood orange.

**Useful information:** Each of these drink vials contain each 10 g of branded collagen FORTIGEL®. This collagen is characterised by its optimal bioavailability and can be absorbed very well by the body in liquid form. Cartilage is made up of 70% collagen. Please remember that regular exercise is important for your joints. Very easy to use: GELASTIN® Liquid extra is filled into vials ready to drink. Powder does not have to be stirred in and no mixing is required. 1 vial every day is sufficient, preferably over a period of 3 months.
